#### **The Charter**



This information sheet is about the Charter of Rights for parents and carers with disability involved with Child Protection in Victoria.

We will call this the Charter.



A charter says what rights people have.

**Rights** are things that belong to everyone.



The Charter says what rights you have if

- You are a parent or carer with disability
- You have a child involved with Child Protection in Victoria.



Child Protection might work with

• Government

Schools

• Police

• Courts.



Child Protection is there to make sure your child is safe.

# What is the Charter for



The Charter is there to help you if you have a child involved with Child Protection.



It tells you

- Your rights
- What Child Protection must do.



The Charter says you have the right to always be a part of your childs life.



The Charter says Child Protection must talk to you every time they help your child.



It says Child Protection must be open and honest with you.

# Who is the Charter for



The Charter is for

- Parents
- Carers
- Other services who help your child.



It helps make sure you get your rights when your child is involved with Child Protection.



The Charter is also for the Child Protection workers who help your child.



The Charter says Child Protection workers should always make sure your child gets their rights.



The Charter is also for other people who might help care for your child.



This could be people like

• Care worker

**Care worker** is someone who helps care for you or your child.

Social worker

**Social worker** is someone who helps with problems in your life.

• Foster carer

**Foster carer** are people who take care of your child.

• Kinship carer

**Kinship carer** is when someone from your family takes care of your child.

# What does the law say



There are laws that say what rights children and people with disability have.

Laws are rules everyone must follow.



The law says every child has rights.



1 of the rights is the right to be safe.



The law says some children may need help to be safe.



It might be Child Protection who helps keep your child safe.



The law says people with disability have the same rights as everyone.



Some of these rights are

- Make decisions
- Have a family
- Be treated fairly.



The Charter says Child Protection must make sure you get your rights when they help you.



The Charter also says that you must get help to

- · Look after your child if you need it
- Make decisions about your child.

## Who should know about the Charter



Everyone who helps families with children involved with Child Protection should know about the Charter.



This means

• The police and courts

• Lawyers



The NDIS



• Services who help people with disability get their rights.

# How will you know about the Charter



Child Protection will give you a copy of the Charter when you first meet them.



They will talk about the Charter with you.



They will tell you what rights you have.



You can ask them questions about the Charter.



Services that help people with disability get their rights will also have the Charter.

## What you can do if you are not getting your rights



You should talk to your Child Protection worker if you are not getting the rights in the Charter.



You can ask for a support person to help speak to your Child Protection worker.



You can make a complaint to the government in Victoria.

You can call the Office of the Public Advocate.

The Office of the Public Advocate helps make sure everyone gets their rights.

COMMISSION FOR CHILDREN AND YOUNG PEOPLE You can call the Commission for Children and Young People.

The Commission for Children and Young People helps the services who look after children.



They make sure these services keep children safe.

The number is **1300 782 978**.



Other people you could call are

- A lawyer
- An NDIS worker
- An advocate.



An **advocate** is someone who helps you get your rights.
