## THE COURT ORDERS THAT:

- The court adopts the Special Referee's report on costs dated 27 April 2023.
- 2. The Scheme Administrator shall pay the contingency funds of \$750,000 into the Distribution Sum.
- 3. The Scheme Administrator shall pay:
  - (a) a sum not exceeding \$24,000 to the Australian Tax Office for the tax liability for

- financial years 2021 and 2022;
- (b) the sum of \$1,373,005.20 to Maurice Blackburn for settlement administration costs and disbursements incurred for the period 1 December 2017 until 28 February 2023; and
- (c) a sum not exceeding \$31,050 to Maurice Blackburn for settlement administration costs and disbursements to finalise the Scheme.
- 4. The Scheme Administrator shall pay any Residual Sum remaining of the Distribution Sum after the deductions authorised by the preceding paragraph of this order to Foundation Murrindindi, also known as Marysville and Triangle Community Foundation (ABN 23160630526) of 3/27 Murchison Street, Marysville, Victoria as a donation towards its charitable objects, and the receipt of the Chairperson or Treasurer of the Foundation shall constitute a release of the final obligation of the Scheme Administrator in respect of the Distribution Sum.
- The proceedings are dismissed with no order as to costs in accordance with paragraph
   of the court orders dated 27 May 2015.
