# THE COURT ORDERS THAT:

### Confidentiality

- 1. Pursuant to s 33ZF of the *Supreme Court Act 1986* (Vic) ('Act') and/or r 28.05(4) of the *Supreme Court (General Civil Procedure) Rules 2015* (Vic) ('Rules'), subject to further order of the Court, each item in:
  - (a) Schedule 1 which is identified as Confidential from Defendant is confidential and must not be published or made available to any persons except:
    - (i) the plaintiffs in this proceeding, and their legal representatives (including their directors and employees) or any counsel briefed by them;
    - the plaintiffs in the Jowene Proceeding, the Teoh Proceeding and the Kajula Proceeding, and their legal representatives or any counsel briefed by them;
    - (iii) any servant or agent of CASL Funder Pty Limited as trustee for CASL
      Fund 1 (ACN 645 229 643) and/or CASL Management Pty Limited
      (ACN 645 229 116); and
    - (iv) personnel of the Court.
  - (b) Schedule 2 which is identified as Confidential from Other Parties is confidential and must not be published or made available to any persons except:
    - (i) the plaintiffs in this proceeding, and their legal representatives (including their directors and employees) or any counsel briefed by them; and
    - (ii) personnel of the Court.

### Consolidation of the Jowene Proceeding and the Lidgett Proceeding

- 2. Pursuant to r 9.12 of the Rules and s 33ZF of the Act, the Lidgett Proceeding be consolidated with the Jowene Proceeding.
- 3. The consolidated proceeding be known as *Justine Lidgett and Cameron Lidgett v Downer EDI Limited* and be identified as S ECI 2023 01835 ('Consolidated Proceeding').
- 4. The plaintiffs in the Lidgett Proceeding are to be the representative plaintiffs in the Consolidated Proceeding.
- 5. Costs incurred in the Jowene Proceeding be costs in the Consolidated Proceeding.

### Consolidation of the Teoh Proceeding and the Lidgett Proceeding

- 6. Pursuant to r 9.12 of the Rules and s 33ZF of the Act, the Consolidated Proceeding be further consolidated with the Teoh Proceeding.
- 7. Following such further consolidation, the consolidated proceeding be known as *Justine Lidgett and Cameron Lidgett v Downer EDI Limited* and is to be identified as S ECI 2023 01835 ('Final Consolidated Proceeding').
- 8. The plaintiffs in the Lidgett Proceeding are to be the representative plaintiffs in the Final Consolidated Proceeding (the 'Plaintiffs').

- 9. Pursuant to s 33ZF of the Act, Maurice Blackburn Pty Ltd ('Maurice Blackburn') is to be the solicitor on the record for the Plaintiffs in the Final Consolidated Proceeding and William Roberts Pty Ltd, t/as William Roberts Lawyers ('William Roberts') is to act as an agent for Maurice Blackburn.
- 10. Costs incurred in the Lidgett Proceeding and the Teoh Proceeding be costs in the Final Consolidated Proceeding.
