## THE COURT ORDERS THAT:

1. Receipt from VLAB of the affidavits of the applicants listed in the Schedule is taken to be an application by those applicants to be admitted to practise to the Australian legal profession as Australian lawyers.

2. When the signature of the applicants listed in the Schedule is extracted from their affidavit and affixed to the Supreme Court roll by the Prothonotary or one of her

delegates, those applicants will be taken to have signed the Supreme Court roll.

3. The applicants listed in the Schedule are admitted to practise to the Australian legal profession as Australian lawyers and officers of the Supreme Court of Victoria.
