- A. The Court is informed that on 11 June 2026, the proceeding was settled at Mediation conducted by the Honourable Associate Justice Efthim.

THE COURT ORDERS THAT:

Court Approval of Settlement

- 1. By **4:00pm on 24 July 2026**, the Plaintiffs are to submit to chambers a notice of proposed settlement ("**Notice**") to be sent to the Group Members, in accordance with paragraph 16.3 of *Practice Notice SC GEN 10*, for the Court's consideration and approval.
- 2. Upon the Court approving the Notice and notification of same being provided to the solicitors for the Plaintiffs, within two (2) business days, the solicitors for the Plaintiffs shall cause the Notice to be sent to each of the Group Members. Such Notice can be sent



by email where an email address is available, or failing that, by express post.

3. By **4:00pm** on **29 July 2026**, the Plaintiffs shall file and serve a Summons in respect of their application for approval of the settlement to be heard at **10:30am on 16 October 2026**.
4. By **4:00pm** on **12 August 2026**, the Plaintiffs shall file and serve any affidavit material (which may include an affidavit to be provided to the Court on a confidential basis) in support of the Summons.
5. By **4:00pm** on **26 August 2026**, the Defendants and any of the Group Members (should they wish to do so) shall file and serve any affidavit material upon which they seek to rely in respect of the Summons.

Other Matters

6. Costs are reserved.
7. Parties have liberty to apply.
