  - (c) Settlement Administration costs for the period 1 October 2016 and 31 October 2016 in the amount of \$258,997.81, being in respect of estimated anticipated, general and I/D settlement administration costs and disbursements are approved;
  - (d) Settlement Administration costs for the period 1 November 2016 and 31 December 2016 in the amount of \$307,948.00, being in respect of estimated anticipated I/D settlement administration costs and disbursements are approved;
  - (e) Settlement Administration costs for the period 1 January 2017 and 31 January 2017 in the amount of \$33,213.00, being in respect of estimated anticipated I/D settlement administration costs and disbursements are approved;
  - (f) Plaintiff's reasonable legal costs and disbursements of the proceeding for the period 1 May 2015 to 27 May 2015 in the amount of \$434,450.43 are approved; and
