 - d. Settlement Administration costs for the period 1 November 2016 and 31 December 2016 in the amount of \$684,146.00, being in respect of estimated anticipated I-D settlement administration costs and disbursements be approved; and
 - e. Settlement Administration costs for the period 1 January 2017 and 31 January 2017 in the amount of \$57,302.00, being in respect of estimated anticipated I-D settlement administration costs and disbursements be approved.
