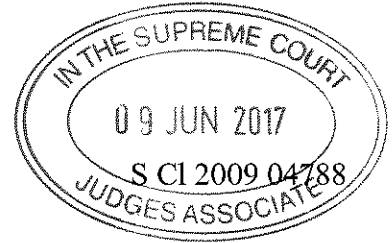

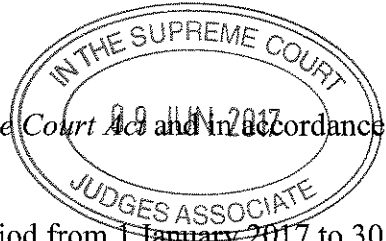

THE COURT ORDERS THAT:

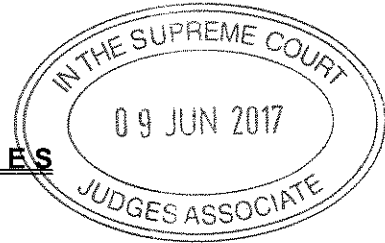
1. Pursuant to sections 33V and 33ZF of the *Supreme Court Act* and in accordance with section 11.1 of the SDS:
 - a. Settlement administration costs for the period from 1 January 2017 to 30 June 2017 inclusive be approved up to whichever is the lesser of:
 - i. \$3,810,117.94; or
 - ii. The amount showing on Maurice Blackburn's finalised settlement administration invoices for the period from 1 January 2017 to 20 June 2017.
