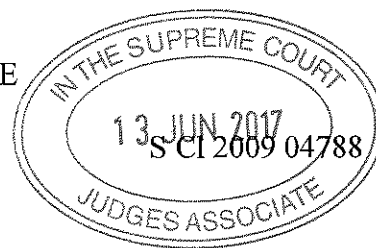

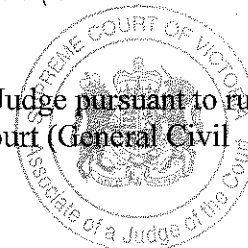

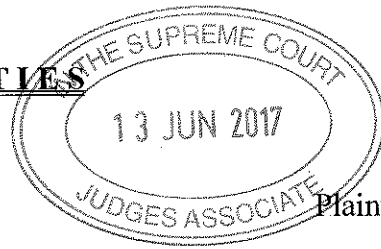
Pursuant to sections 33V and 33ZF of the *Supreme Court Act* and in accordance with section I1.1 of the SDS:
